## TERMS OF SALES

### Price

Prices for the rooms (chambres d'hôtes) include accommodation, breakfast, daily cleaning and change of towels when necessary. Prices for the cottages (independant houses) only include accommodation. We offer the possibility to order breakfast baskets at the price of €15 per person. Cleaning at the end of stay or during the stay is charged €40.

Total price is based on a precise number of people. The owner can refuse accommodation for each additional person not specified in the contract without this being considered as a modification or termination of the contract on its own initiative.

### Booking - Down payment

Booking will be confirmed only after receipt of a down payment of 30% of the full price which will be deducted from the final bill.

When booking online, your credit card detailed information are requested in order for us to recover the down payment and therefore guarantee the booking. We commit not to keep your credit card numbers.

### Cancellation

When cancellation occurs more than 14 days before the stay, the down payment is returned to the client.

When cancellation occurs less than 14 days before the stay, the down payment remains with the owner.

In case of no show or late cancellation within 72 hours before the stay, the full price of the stay is due to the owner.

In case of shortened stay, the total price the stay initially scheduled remains fully due to the owner.

### Time of arrival and departure

Check-in times are between 4pm to 8pm. In case of late arrival, please contact the owner in advance by phone.

Check-out times are before 12am for rooms and 10am for cottages. A later departure may be possible under the owner prior approval.

### Payment

The balance will be paid on arrival. The local tourist tax of €0.85 per day per adult is charged on top and is paid back to the city of Villerville.

Extra (bar, optional services) that are not explicitly included in the rates will be payable at the end of the stay.

Payments must be made by credit card, by bank transfer or by cash.

### Pets

Pets are not allowed on the venue.

### Use of premises

Smoking in the rooms and cottages is prohibited.

The customer is committed to leave the room or cottage in perfect condition at the end of the stay and to inform the owner and financially assume any possible degradation he may be responsible for.

### Pool and Tennis court

Pool and tennis court are access free.

Not accompanied children are not allowed to go to the swimming pool. Parents are requested to look after their children to prevent any accident and disturbance.
